The National Small Industries Corporation Ltd. a Govt. of India Enterprises having its, registered office at NSIC Bhawan, Okhla Industrial Estate, New Delhi-110020 (hereinafter referred to as NSIC which expression shall unless repugnant to the meaning or context thereof mean and include its successors and permitted assigns) of the second Part.

Whereas the parties had executed an MOU dated 12th July 2006 a copy of which is annexed hereto and marked as annexure "A". As per the said MOU the NSIC and Yes Bank have agreed for facilitating credit to MSME's for three years. The said three years has since expired on 12th July 2009. Now 'Yes Bank' has approached NSIC for extension of the MOU for another three years on the same terms and conditions as are enumerated in the above referred MOU dated 12th July 2006.
